## House Rules

### GENERAL PRINCIPLES

Párisi Udvar Hotel Passage Operating Hours:

Monday – Sunday: 10:00 AM – 10:00 PM

The Párisi Udvar Hotel Passage is a privately owned area open to the public, where the operator reserves the right to set conditions for services, as outlined in the house rules. These rules establish the principles and guidelines that ensure the high standard of operation, reputation, and enhancement of the Párisi Udvar Passage (hereafter referred to as “the Passage”). They also ensure a peaceful and enjoyable experience for visitors.

All individuals present in the Passage, including guests (hereafter referred to as “guest” or “guests”), are required to adhere to the rules set forth in the house rules. Guests must respect the dignity and personal rights of the hotel and restaurant staff, as well as security personnel.

In addition to guests using the hotel's and restaurant's services, a maximum of five visitors at a time are allowed in the Passage. Groups of more than five visitors can only be accommodated with prior arrangement. The furnishings within the Passage are reserved for the use of our guests who are consuming services. Visitors passing through the Passage without using the services are not permitted to use these furnishings.

The safety and well-being of children, including their awareness of and compliance with the house rules, is the responsibility of the accompanying guest.

It is expected that all guests respect one another, behave courteously, and dress appropriately.

Only dogs on a leash and fitted with a muzzle are allowed in the Passage and the restaurant. No other pets are permitted.

### PROHIBITED ACTIVITIES

- Entry is prohibited while wearing a helmet, full-face coverings, swimwear, or without a shirt or pants, or barefoot.
- Bicycles, skateboards, scooters, roller skates, and other vehicles are not allowed in the Passage.

- Guests are not allowed to engage in any advertising or commercial activities in the Passage.
- Consuming food or drink purchased elsewhere is not allowed in the Passage or the restaurant.
- Smoking and the use of electronic cigarettes are prohibited in the Passage.
- Open flames, lighters, or any other means of starting a fire are not permitted in the Passage.
- The possession, distribution, or use of illegal drugs is strictly prohibited.
- Bringing sharp objects, weapons, pyrotechnics, or any other items that could endanger personal safety is prohibited. The operator reserves the right to determine what constitutes such items based on the situation.

Any individual exhibiting provocative, antisocial, or violent behavior that could cause distress or alarm to others, or who resists lawful measures taken by event organizers or authorities to maintain order with violence or threats, may be removed by security and reported to the police.

Activities causing excessive noise, unpleasant odors, or other environmental disturbances that disrupt others in the Passage or the restaurant are prohibited.

Any activities outside the intended use of the building, or any commercial activities, can only be conducted with the express permission of the hotel manager.

Staff may refuse service to individuals who violate these general principles and behavior norms. Security personnel may remove such individuals from the Passage after a formal warning.

This house rule is valid until further notice.
